##### C. ATHLETE ELIGIBILITY

###### C.1. Compliance with the Olympic Charter and other relevant rules

All athletes must respect and comply with the provisions of the Olympic Charter currently in force, including but not limited to Rule 41 (Nationality of Competitors) and Rule 43 (World Anti-Doping Code and the Olympic Movement Code on the Prevention of Manipulation of Competitions).

Only those athletes who respect and comply with the Olympic Charter, the World Anti-Doping Code and the Olympic Movement Code on the Prevention of the Manipulation of Competitions, including the



conditions of participation established by the IOC, plus the rules of IHF, may participate in the Olympic Games Paris 2024.

### C.2. IF additional eligibility criteria/requirement:

- Athletes must be eligible to play for their national team as per IHF [Regulations](#). Details stipulated in the [IHF Player Eligibility Code](#) and in the [IHF Regulations for Transfers between Federations](#).
- Athletes must be at least 16 years of age as stipulated in Regulations for IHF Competitions article [3.2.1.2](#), meaning that players eligible to participate have to turn 16 on the day of their first match at the latest.

## D. QUALIFICATION PATHWAY

### D.1. QUOTA PLACES

The qualification events are listed in hierarchical order of qualification.

	<p><u>QS 1 and 5</u> will be allocated to the highest placed continent at the 2023 World Championship. The highest ranked team (QS1) and next highest ranked team (QS5) at the respective continental qualification event not yet qualified and not yet selected to participate in the IHF Qualification Tournaments will obtain the corresponding quota place.</p> <p><u>QS 2 to 4</u> are allocated to the second (QS2), third (QS3) and fourth (QS4) highest placed continents at the 2023 World Championship. The highest placed teams at the respective continental qualification event not yet qualified and not yet selected to participate in the IHF Qualification Tournaments will obtain the corresponding quota place.</p> <p>In the case of the Continental Confederations of North America and the Caribbean and South and Central America, the ‘best continent’ positions will be allocated based on the ranking at the respective combined continental qualification event.</p> <p>Example: Even though e.g. BRA (belonging to South and Central America) is the best team from North America and the Caribbean and South and Central America, the corresponding place to be allocated to the next highest ranked NOC at the combined continental qualification event might be allocated to e.g. CUB (belonging to North America and the Caribbean).</p> <p><u>QS 6:</u> If any team from Oceania is placed between 8<sup>th</sup> - 12<sup>th</sup> at the 2023 World Championship, this qualification quota place will be allocated to the highest placed NOC at the event in which Oceania can qualify and which is not yet qualified. If this is not the case, this qualification quota place will be allocated to the second highest placed continent at the 2023 World Championship, in addition to QS2. The NOC of the highest placed team at the respective continental qualification event which is not yet qualified for the Olympic Games or the Olympic Qualification Tournament will be allocated the quota place.</p> <p>The NOCs/NFs participating in the Olympic Qualification Tournaments, must confirm their participation in the Olympic Games to IHF in case they obtain a quota place at the same time as registering their team(s) for the Olympic Qualification Tournaments. i.e. by 15 February 2024.</p>

In the event that the 2023 World Champion or the host country of the Olympic Games Paris 2024 also wins the continental qualification, the NOC of the next highest ranked team of the respective continental qualification event will obtain the quota place.

If one (1) or more teams placed between 2<sup>nd</sup> - 7<sup>th</sup> at the 2023 World Championship have already qualified for the Olympic Games at their respective continental qualification events, the team

Hence, also all following teams (5<sup>th</sup> - 7<sup>th</sup>) will move one spot forward, with the spot originally foreseen for the 7<sup>th</sup> ranked team now being open for the team ranked 8<sup>th</sup> at the World Championship.</i></p> <p><u>QS 1 and 5</u> will be allocated to the highest placed continent at the 2023 World Championship. The highest ranked team (QS1) and next highest ranked team (QS5) at the respective continental qualification event not yet qualified and not yet selected to participate in the IHF Qualification Tournaments will obtain the corresponding qualification quota place.</p> <p><u>QS 2 to 4</u> are allocated to the second (QS2), third (QS3) and fourth (QS4) highest placed continents at the 2023 World Championship. The highest placed teams at the respective continental qualification event not yet qualified and not yet selected to participate in the IHF Qualification Tournaments will obtain the corresponding qualification quota place.</p> <p>In the case of the Continental Confederations of North America and the Caribbean and South and Central America, the 'best continent' positions will be allocated based on the ranking at the respective combined continental qualification event.</p> <p>Example: Even though e.g. BRA (belonging to South and Central America) is the best team from North America and the Caribbean and South and Central America, the corresponding place to be allocated to the next highest ranked NOC at the combined continental qualification event might be allocated to e.g. CUB (belonging to North America and the Caribbean).</p> <p><u>QS 6:</u> If any team from Oceania is placed between 8<sup>th</sup> - 12<sup>th</sup> at the 2023 World Championship, this qualification quota place will be allocated to the highest placed NOC at the event in which Oceania can qualify, not yet qualified. The NOC of the highest placed team at the respective continental qualification event which is not yet qualified for the Olympic Games or the Olympic Qualification Tournament will be allocated the qualification quota place.</p> <p>The NOCs/NFs participating in the Olympic Qualification Tournaments must confirm their participation in the Olympic Games to IHF in case they obtain a quota place at the same time as registering their team(s) for the Olympic Qualification Tournaments, i.e. by 15 January 2024.</p>

## D.2 HOST COUNTRY PLACES

The host country will automatically qualify one (1) men's team and one (1) women's team of fourteen athletes on the condition that the athletes meet the eligibility requirements described under section C of this document.



## E. CONFIRMATION PROCESS FOR QUOTA PLACES

### E.1 CONFIRMATION OF QUOTA PLACES

IHF will publish the final results after each qualification event on the official [website](#) and inform the qualified NOCs/NFs accordingly.

The NOCs will then have two (2) weeks to confirm if they wish to use these quota places, as detailed in paragraph H. Qualification Timeline.

The qualified NOCs from the IHF Men's and Women's Olympic Qualification Tournaments must confirm their participation in the Olympic Games Paris 2024 in case of qualification to the IHF at the same time when registering the team(s) for the IHF Olympic Qualification Tournaments.

### E.2 CONFIRMATION OF HOST COUNTRY PLACES

The host country must confirm in writing to the IHF by 31 July 2023 the use of its host country places.

## F. REALLOCATION OF UNUSED QUOTA PLACES

### F.1 REALLOCATION OF UNUSED QUOTA PLACES

If an allocated quota place is not confirmed by the NOC by the confirmation of quota place deadline or is declined by the NOC, the quota place will be reallocated to the next highest-ranked eligible team, not yet qualified, at the event at which the quota place was obtained.

### F.2 REALLOCATION OF UNUSED HOST COUNTRY PLACES

Unused host country place(s) will be allocated to the continent of the 2023 World Champion in the respective gender and allocated to the highest placed NOC from this continent, which has not yet qualified at the corresponding continental qualification event.

## G. AP ALTERNATE ATHLETES

Each qualified team is entitled to three (3) Ap alternate athletes

#### Definition:

Ap athletes are non-competing athletes accredited in the "Ap" category who have different entitlements to competing athletes (accredited as "Aa") as described in the "Ap" accreditation quotas and conditions



outlined in the IOC Accreditation Guide. These alternate athletes are not part of the athlete quota as described in Paragraph **B. Quota Places**. “Ap” alternate athletes could become competing athletes only under the conditions outlined in the IOC/Paris 2024 Late Athlete Replacement policy.

Eligibility:

Alternate athletes must comply with the same eligibility rules as competing athletes as described in paragraph **C. Athlete Eligibility**.
